EXPRESS CONTRACTUAL ASSUMPTION OF ALL RISKS WAIVERS OF AND RELEASE FROM ALL LIABILITY FOR ANY NEGLIGENCE AND INDEMNITY FOR ALL THIRD PARTY CLAIMS. I know that skateboarding, in-line skating, and bicycle riding are inherently dangerous sports and activities in which I choose to voluntarily participate at my own risk. I am aware that the usual risks, hazards and dangers of personal injury, death, and disability or property damage and loss, necessarily increase when using ramps, curbs, steps, half-pipes, inclines or declines, bowls or any other structure and device. I know that the risks, hazards and dangers include but are not limited to, uncontrollable boards and bicycles, falling, jumping, landing, performing tricks, colliding with other users, staff, media personnel, spectators and fixed objects. I also understand that these risks, hazards and dangers are further increased when other persons, whether or not of the same level of experience or skill, are present at the same time and using the same facilities. (All of the above-defined activities are collectively referred to throughout this agreement as the "Hazardous Activities").

By this agreement it is my intention to relieve Alpine of any duty to me and I do assume the entire risk of any of the damages which might occur or as a result of my use of or presence at the park. By this agreement, I also intend to release, discharge and absolve Alpine Ventura, LLC from any and all liability for any claim, damage, personal injury, disability, death, medication and any other type expense or property damage or loss (collectively referred to throughout this agreement as ("the Damages")), caused by and because of any negligence of Alpine and promise not to sue or exercise any legal right to seek damages from Alpine.

In consideration of utilizing the Alpine Ventura LLC Skateboard Park, facility, I agree as follows:

- As to my participation in any activity, including but not limited to, the Hazardous Activities and as to any and all liability for the Damages which I may suffer to incur due to any cause whatsoever, while in the interior or exterior of the premises of the Alpine Ventura LLC Skateboard Park facility (collectively referred to throughout this agreement as the "Park"), I hereby agree:
  - To waive any and all claims for Damages that I may have against Alpine Ventura LLC, their members, managers, employees, officers, associates, agents, contractors, volunteers sponsors, vendors, or exhibitors, family, or any other person or company in any way associated with Alpine Ventura LLC (collectively referred throughout this agreement as "Alpine")
  - To release Alpine from any and all liability for the Damages that I may suffer or incur, or that my next of kin may suffer as result of my participation in any activity, including but not limited to, the Hazardous Activities while at the Park; and
  - To hold harmless and indemnify Alpine from any and all liability for the Damages to any third party resulting from my participation in any activity, including but not limited to, the Hazardous Activities while at the park.
- This waiver and release of liability and indemnification agreement (collectively referred to hereafter as "Waiver and Release") shall be effective and binding upon my heirs, next of kin, family, relatives, guardians, conservators, executors, administrators, trustees, and assigns in the event of my injury, disability, or death.
- I have read, understand, and agree to be bound by the Standards of Conduct (which are listed on the other side of the "Waiver and Release") governing my conduct while using the park. I understand these rules are strictly enforced.

I hereby certify that I am at least 18 years old. I have completely read and understand this Waiver and Release and its terms. Prior to signing this Waiver and Release I have had the opportunity to ask any questions about the Waiver and Release, Alpine, or the Park. I am aware, that by signing this Waiver and Release I assume all risks and waive and release certain rights that I and my heirs, next of kin, family, relatives, guardians, executors, administrators, trustees, and assigns may have against Alpine.
